**Storage Period-Fall 2023 through 6/1/2024**

- \* Boat registration or Certificate of Documentation
- \* Boat Owner's Driver License or valid I.D.
- \* Boat's Insurance I.D. card or proof of insurance

**Payment for storage Fall 2023 must be received, in full, prior to being hauled – no exceptions will be granted.**

The Yard Master at any-time prior to hauling (even upon arrival at the Marina/slings) for any reason can refuse the hauling/storing of your vessel. At the Yard Masters discretion an additional security deposit may be required based on vessels condition and value. If storage is denied, any funds already remitted to be refunded within 5 business days

Any vessel remaining in the yard of the C.P.Y.C. without a valid contract past May 31, 2024 will be subjected to a \$15.00 daily storage fee. If boat must be moved for operational needs, \$100.00 relocation fee will be applied.

All payments are due no later than 30 days from date on invoice. If no payment is received within 30 days, the College Point Yacht Club reserve the right to start Legal action against the boat owner(s) and /or process a lien on such vessel. All legal costs and filling fees incurred by these actions will be the sole responsibility of the boat owner.

**I herewith agree to remain personally responsible for any and all debts, costs, fees, monies, etc. due to the Club incurred for the storage of my vessel, including past due storage and disposal fee if the vessel is abandoned.**

By signing this contract, I agree to the above and to abide by all Marina and Boatyard rules.
